

Profile of Great One Foundation

Introduction:

Great One Foundation is a non-Govt., non-profit, voluntary and social welfare organization working in the Country. It was established in 2000 with active initiative of some social workers of Dhaka district at promoting the life status of poor and disadvantaged people especially women, Adolescent, Children and Disabled. Great One foundation is commuting the socio Economic development for the poor communities of the country. The mended of Great One Foundation is to work for the poor and the distress section of the community with the main stream of development Process.

We sensitise duty bearers on their roles and responsibilities for greater accountably and more responsive authorities; and empower communities to claim their all rights through engaging more actively with local government.

We demonstrate model solutions, and enable wider replication through advocacy and capacity building to broaden coverage.

We integrate anti-social campaign into other areas of development and bring in elements from health, education, nutrition and other sectors into our work. We actively pursue mutually respectful and accountable partnerships with diverse entities to support our multifaceted work.

We strive for the highest quality and durability in our interventions, and work to improve sector performance and accountability through monitoring and tracking for more sustainable social services.

We centralise learning and innovation, both in technological and operational elements of our programmatic work, as well as through rigorous, multidisciplinary research.

We create and promote an organizational culture that builds on the energies of each and every members which builds a collective vision of community development. By working collaboratively with others, the needs of the community are discovered, and the mission of the organization begins to emerge clearly.

Through our widespread network of passionate team members we make personal one to one contact to the individual poor, oppressed, landless farmers, destitute woman, vulnerable children, widow, destitute man and women, day laborers, unemployed male and female youth, drug addicts, tanagers, street children, and to bring them under the umbrella of small viable groups for their organization and development.

We promote the socio-economic condition of the most vulnerable oppressed people way to creating awareness, provide training and financial support for their self-reliance and empowerment, mainly destitute and disadvantaged vulnerable men, women and children are socio-economically empowered.

According to Bangladesh Narcotics Control Department (NCD), of the total 165 million people, about "seven million" are addicted to drugs. For years, the drug laws were not firmly implemented."Yaba", "Phensedyl syrup", and "marijuana" are the commonly abused drugs in Bangladesh allegedly trafficked from Myanmar and India.

Approximately 85 per cent of drug addicts are male young people of around 15 to 30 years old. They use prohibited drugs mainly due to utter frustration and hopelessness in life.

Consumption of both opium and cannabis are traditional in Bangladesh. Other drugs such as heroin began to be smuggled into the country only in the 1980s. The smuggling, diversion and abuse of pharmaceuticals originating from India is considered the single largest drug problem in Bangladesh. The Foundation launches another anti-drug campaign to stop the drugs abusing.

On September 25, 2015, at the end of the deadline for the Millennium Development Goals (MDGs), the UN General Council drew up Sustainable Development Goals (SDGs) in their place. One of the criticisms of MDGs was that the issues of women's rights had not been wholly included. Surpassing this criticism, achieving gender equality by removing all forms of violence and discrimination against women and girl

children has been identified as the top priority of the 17 SDGs and the pledge to "leave no one behind" has been taken. The fifth goal is to achieve gender equality and to empower women and girl children. Under this goal, the objectives to remove all forms of discrimination against women and girl children, to stop all forms of personal violence including trafficking and sexual harassment, and to eliminate harmful social practices such as child marriage and forced marriage, have been set.

To achieve the SDGs related to women and girl children, Bangladesh government needs to consider some issues with importance.

Only the government could not achieve the goal. So that, the foundation working on women and child rights.

Health workers are concentrated in urban secondary and tertiary hospitals, although 70% of the population lives in rural. Major challenges include: an overly- centralized health system, weak governance structure and regulatory framework, weak management and institutional capacity in the Ministry of Health and Family Welfare (MoHFW), fragmented public service delivery, inefficient allocation of public resources, lack of regulation of the private sector – which employs 58% of all physicians, shortage of HRH, high turnover and absenteeism of health workers, and poor maintenance of health facilities and medical equipment.

The foundation starts advocacy on the need of adequate and skilled health workforce for well functioning health system and advocate for the process as initiated by the Foundation.

All citizens must undertake twelve years of compulsory education which consists of eight years at primary school level and four years at high school level. Primary and secondary education is financed by the state and free of charge in public schools. Great One Foundation try to help all poor students.

Bangladesh is a disaster-prone country of an area of about 1,47,570 sq. km. with population nearing 140 million. The country is well within the tropics and is the largest delta in the world formed by the mighty rivers namely the Ganges, the Brahamaputra and the Meghna.

Bangladesh has special geographical feature. It has the Himalayan range to the north. The Bay of Bengal to the south with its funneling towards Meghna estuary and the vast stretch of Indian land to the west. The combined affects of the role played by this special geographical features have significant bearing on weather system of Bangladesh. The weather system are not always favourable.

Due to this weather system, Bangladesh becomes the worst victim of natural calamities causing colossal loss of lives and properties. Most of the people of this country are very poor. It is predominantly an agricultural country. The economy largely depends on weather. Major disasters that occur in Bangladesh are : tropical cyclone, tidal bore, flood, tornado, river bank erosion, earthquake etc.

A large number of poor people are to live in vulnerable areas of the southern part of Bangladesh. The vulnerability is so miserable that they have to go and settle in the newly accreted land in Bay of Bengal and its surrounding areas which is occasionally hit by tidal bore or devastating cyclone.

The adverse impacts of all the natural hazards affecting socio-economic condition need to be reduced for sustainable development. Realization of this reality, the Great One Foundation has undertaken a lot of plans and programs for disaster reduction through disaster management.

Bangladesh got hit by a pandemic named Covid – 19. But we didn't sit back, we did many activates such as we alerted peoples, we disinfected the roads, we distributed food to the needy peoples for 15 days. Even the season of dengue arrived; we tried to diminish it with medicines. The foundation has worked against the shopkeepers who used to sell duplicate masks, sanitizers etc. In this pandemic times road outside the Mitford hospital becomes so crowded because of the little shops on the footpath, leading the patience to have trouble while going to the hospital and even the patience who came just to test for Covid – 19. When we tried to fix this problem, we had to go though many threats then sent a letter to Dhaka south city corporation, Dhaka metro police commissioner and the director of Mitford hospital but it didn't worked yet. After getting the responsibility of community ambassador of south city corporation , the landlords who built their house over the drain way, which caused drain blockage and roads were flooded by the drain water, it also trouble the people to walk on the road. There was a fear of dengue for this

flooded water. Then I fixed and rebuilt the drain way but the landlords were unhappy about that and tried to threat me. Still the foundation continued the work.

Organizational structure and Management:

Execution & Management of the organization:

Great One Foundation adopt decentralized participatory management system in program implementation. The General body, the supreme authority of the organization consists of 21 members. A 7 member Executive committee is elected biennially out of General body for policy making and program execution. All the policies of executive committee are implemented by the modest staff headed by the Secretary, who is responsible for overall program implementation and management.

At top, mid and field level, the activities of Great One Foundation are managed by development workers with long year's professional experiences. Its programs are implemented through participation of all levels of workers within the frame work of Action-plan. Each level of management is encouraged to accept council and advice of the authority concerned to embrace creative solution. They are also encouraged for team sprit and to motivate them to know much. Great One Foundation provides its workers liberty to take initiative, stimulating participation and continuous search for up-gradation in terms of quality and quantity.

Project Management:

Project staffs are appointed and set for the project implementation. Generally for every project a project implementation Committee is formed with participation of the staff, EC members and Project participants (maximum) to implement the project through monthly meeting, where they review the progress and find out lacking and make decision for better implementation. A purchase Committee is formed for every project for purchasing project materials. Monitoring and internal evaluation & Audit committee are formed for each project for conducting internal audit, evaluation half yearly basis and quarterly monitoring.

All the staffs are made accountable to their immediate supervisors.

Each and every project has a setup like Executive Director > Program Director > Field coordinator > Upazila /thana Manager>Supervisor > Field staffs > Group cadres/leaders etc.

Everyone is responsible and accountable to the immediate supervisor. Staff members sit in the monthly meetings and review the performance of the project and find out drawbacks and they also find out the solutions through sharing and joint discussion.

Financial policy of the organization:

Great One Foundation is financially capable to implement any kind of development program. The Fund, receiving from different sources for the purpose of the organization, is accumulated into a Bank account. If the money is Great Oneed to withdraw from Bank , the transaction is dealt with joint signatures of the President, Secretary and treasurer. Yearly budget of the organization is approved in the General meeting for every year.

Quality Control:




Monitoring:
